

By order of the Chief Judge, on March 23, 2020, the District of Columbia Court of Appeals adjusted its operations to address concerns regarding the Coronavirus (COVID-19) and cancelled oral arguments through May 31, 2020. The court plans to issue another order regarding operations subsequent to May 31, 2020, which will further address oral arguments. All cases scheduled for the June 2020 Regular Calendar will be heard by a panel of judges via videoconference. All cases scheduled for the June 2020 Summary Calendar will be considered by a panel of judges starting on the scheduled date. The court is currently finalizing procedures for remote oral argument, and parties and counsel should check the court's website for additional information on how the court will proceed.
