



**Superior Court of the District of Columbia**  
**Public Access for Remote Court Hearings**  
**(Effective September 7, 2021)**

Most of the Superior Court remote hearings are open to the public. You can participate by telephone or online. There is also limited space onsite to observe jury trials.

Audio and video recording; taking pictures of remote hearings; and sharing the live or recorded remote hearing by rebroadcasting, live-streaming or otherwise are not allowed.

**Public Access for Jury Trials**

The WebEx link to observe the criminal jury trial online and password to listen by telephone will change every day. Civil jury trials will be held in Courtroom A-45 or Courtroom B-53. The WebEx link for civil jury trials is listed below.

To join the criminal jury trial by telephone, dial 844-992-4726 (toll free) or 408-418-9388 (toll) and enter the event number as listed below and then press ##. To observe the hearing by video, click the Online WebEx link below and enter the generic log in information as indicated below in red. Do not enter your personal name and email address. You do not need to change the default password.
