**YOU ARE ORDERED TO APPEAR FOR A PRETRIAL HEARING** scheduled on, **September 8, 2021 at 10:00 a.m.** before Magistrate Judge Janet Albert. You are required to attend this hearing. The hearing will be held **REMOTELY** in **Courtroom JM-10** of the D.C. Superior Court, 500 Indiana Avenue, N.W., Washington, D.C. You have the right to seek custody of the minor child, M.D.D., or to challenge challenge the allegations contained in the Government's Motion for Termination of the Parent and Child Relationship. However, in order to do so, you must either appear at the TPR hearing or file a written objection prior to the trial with:

If your appearance is not entered on or before the trial, the trial will proceed in your absence. Any orders or findings of the Court issued at any time will become final unless you make an appearance before the conclusion of the TPR trial.
