SOLICITATION QUESTIONS & ANSWERS: ROUND 02

- Q.1 As this project is subject to Davis Bacon which implies either DC Funding or Federal Funding greater than \$2k are part of this project please advise what laws are applicable for DC Courts construction?
 - a. Please advise if there are any project specific District of Columbia requirements on this project such as:
 - i. Is this project subject to and DOEE First Source Requirement for utilization of DC Resident Labor;
 - ii. Is this project subject to any S/CBE DC requirements for utilization of DC based businesses?; or
 - iii. Is this project subject to DC Apprenticeship laws (Title 7 of DCMR / Chapter 11) or is this project governed only by Federal requirements for apprenticeship?
 - iv. If no DC requirements, are there any goals for any small / disadvantaged business requirements (SDB/SB/Hubzone/8a SDB/WOSB/VOSB)?
- A.1 The response to all of the above is No.
- Q.2 In Attachment K Under demolition, will any categories for tools, consumables, equipment be added or should the skilled labor include all tools and equipment to perform the demolition work?
- A.2 Unit prices shall be prepared as noted per Section B.6.1 of the RFP. In addition, the contractor is allowed to add additional line items to the Schedule K as necessary.
- Q.3 In Attachment K Under HAZMAT Testing & Abatement and under Demolition, how will the subtotal be derived or are there estimated quantities to multiply against?
- A.3 Reference response reflected in A2 above.
- Q.4 In attachment K Under HAZMAT Testing & Abatement there are multiple items asking for pricing within a NPE containment can there be a line item to construct the NPE containment?
- A.4 Reference response reflected in A2 above.

- Q.5 In attachment K Under HAZMAT Testing & Abatement there no line items for the Industrial Hygienist to perform during abatement oversite and clearance testing can these be added?
- A.5 Reference response reflected in A2 above.
- Q.6 In attachment K Under HAZMAT Testing & Abatement there no line items for floor tile adhesives / mastics can these be added?
- A.6 Floor tile adhesives/mastics is included within line item "Removal of asbestos-containing flooring materials (including floor tiles, vinyl sheeting, and carpet/linoleum (if not separated) within a reduced negative pressure containment, per square foot" of the Schedule K.
- Q.7 In attachment K Under HAZMAT Testing & Abatement there no line items the trade asbestos abatement permit from DOEE and or lead paint permit fees Are these part of Permits or should it be added to Testing & Abatement?
- A.7 The permit allowance has been allocated to cover all related permits required of the D-B Contractor associated with this effort.
- Q.8 In Attachment K Under Demolition, under haul off is this per roll off container or what does the Haul off consist of?
- A.8 Under Demolition, the "Haul Off" line shall reflect a per container cost.
- Q.9 In Attachment K Under HAZMAT Testing & Abatement, there are not line items for FLM's Light ballasts; freon can these be added?
- A.9 The contractor is allowed to add additional line items to the Schedule K HAZMAT Testing & Abatement category as necessary.
- Q.10 In Attachment K Under HAZMAT Testing & Abatement, how will pre-abatement demolition be incorporated into the unit rates can the demolition skilled laborer rate be utilized?
- A.10 The Demolition Allowance encompasses all levels of demolition required for the project.
- Q.11 In Attachment K Under HAZMAT Testing & Abatement, on the hazardous materials survey and report what is included in the Hazardous Material Survey and Report Line item:
 - b. Will the IH be performing testing for:
 - i. Asbestos
 - ii. Mercury Lamps
 - iii. PCB Ballast
 - iv. DEHP Ballasts
 - v. Freon
 - vi. Lead paint
 - vii. Mercury
 - viii. PCB in caulks (interior and exterior)
 - c. As this is a lump sum cost and will this price incorporate tested on concealed items?
 - d. Are there as-builds for the existing Building A and B?
 - e. Is there an existing Asbestos Management Plan in place for the buildings Is so please provide for bidders to review
 - f. Dependent on how much hazardous materials there are the costs of the survey will rise to determine the amount of each type of material. Can this be the cost be based on tests performed and inspection time and report time?
